BE IT ENACTED BY the Town Board of the Town of Richfield
Otsego County, State of New York

That it shall be lawful for any authorized organization,
upon obtaining a license therefore, as provided in the
General Municipal Law of the State of New York, to conduct
the game of Bingo within the territorial limits of the
Town of Richfield, subject to the provisions of the
Bingo Control Law of the State of New York.
